Terms and conditions to Processing the Datasheet of Identified Beedi Workers

The Terms and Conditions to process the datasheet of Identified Beedi Workers are as under.

- i) The interested party must have a valid GST Number, PAN No, TAN No etc.
- ii) All applicable Labour Laws including minimum wages of Central Government to the employees of the agency engaged for the work should be complied with.
- iii) Agency should have minimum of 3 years experience in the same nature of work.
- iv) The agency should have been registered with the Government authorities concerned and a copy of each of the registration shall be attached with the bid.
- v) It should not have been blacklisted by any Government Organisation.
- vi) The L1 Party may carry the datasheets to their premises for convenience of work.
- vii) All the expenses shall be borne by the party i.e. Systems, Electricity, DEO etc.
- viii) On completion of Data Entry, the physical documents should be handed over to this office on daily basis with soft copy in a closed CD of the same.
- ix) The undersigned reserves the right to select L1, L2 and L3, considering the quoted rate and infrastructure of the party.
- x) The Software should be developed by using both Front-end and Back-end applications by the agency.
- xi) The agency should make necessary changes as and when required by the office during the aforesaid work.
- xii) Payment will be made in phased manner after verifying the correctness of data supplied by the party in soft form.
